

Terms and conditions for the Prize Draw

1. The Promoter of this Prize Draw is Volleyball England, SportPark, Loughborough University, 3 Oakwood Drive, Loughborough, LE11 3QF.
2. This Prize Draw is open to UK residents aged over 18 who meet the criteria outlined in these terms and conditions. The Prize Draw is not open to employees of Volleyball England, their families, agents, or any third party directly associated with the administration of this prize draw.
3. To enter the Prize Draw you must have an active Club Affiliation on VolleyZone for the 2023/24 season.
4. To enter the prize draw you must have completed the Volleyball England Club Survey 2023/24 in full and provided your name and email address when instructed.
5. Only one entry per person is permitted. Multiple submissions of the same survey, or from the same club will not result in additional entries into the prize draw.
6. The closing time and date for the Prize Draw is 09:00 on Monday 5th February 2024. The Prize Draw will be made before 17:00 on Monday 12th February 2024.
7. The winner(s) will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process administered by the promoter.
8. The first name drawn will receive a free Volleyball England Club Affiliation for the 2024/25 season.
9. The second name drawn will receive a free place on an Assistant Coach Award course.
10. The third name drawn will receive a free place on a Grade 4 referee course.
11. The fourth name drawn will receive a £100 VolleyStore Voucher.
12. The fifth name drawn will receive 6 Mikasa MVA200 Indoor Volleyballs.
13. The promoter accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
14. The promoter accepts no responsibility for any costs associated with travel and accommodation.
15. The winner will be notified by email on the day of the drawing. If a winner does not respond to the promoter within 5 working days of being notified, then the winner's prize will be forfeited, and Volleyball England shall be entitled to select another winner in accordance with the process described above. 30. These terms and conditions shall be governed by English law and the courts of England and Wales shall have exclusive jurisdiction.
