

Terms and conditions for the Prize Draw

1. The Promoter of this Prize Draw is Volleyball England, SportPark, Loughborough University, 3 Oakwood Drive, Loughborough, LE11 3QF
2. This Prize Draw is open to UK residents aged 16 who have booked onto one of Volleyball England's online Commonwealth Games Activator Courses, which are taking place between 11th – 22nd July. The Prize Draw is not open to employees of Volleyball England, their families, agents, or any third party directly associated with the administration of this prize draw.
3. To enter the Prize Draw you must successfully have completed the online activator training, organised a 'come and try it' session and reported information on attendees, including numbers, to Volleyball England by 00:01 on 1st October 2022.
4. Only one entry per club is permitted. Therefore, only one member from each club represented on the activator training dates will go into the draw.
5. If there are fewer than 15 learners attending the combined course dates, one winner will be selected. Two winners will be selected if between 15-30 learners attended the course dates. If there are more than 30 people attending the course dates three winners will be selected.
6. The closing time and date for the Prize Draw is 21st July 2022. Entries will not be possible past this point as course bookings will have closed. The Prize Draw will be made on Monday, 10th October 2022.
7. The winner(s) will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process administered by the promoter.
8. The winner(s) will receive a free place on an Assistant Coach Course. This usually costs £160. This must be redeemed by Sunday, 1st October 2023.
9. The promoter accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
10. The winner will be notified by email on the day of the drawing. If a winner does not respond to the promoter within 90 days of being notified, then the winner's prize will be forfeited, and Volleyball England shall be entitled to select another winner in accordance with the process described above. If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited, and the promoter shall be entitled to select another winner.
11. The prize is non-exchangeable, and non-transferable.
12. Volleyball England reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the promoter's control make it necessary to do so.
13. Volleyball England shall use and take care of any personal data you supply to it as described in its [Privacy Policy](#), and in accordance with data protection legislation. By entering the Prize Draw, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Prize Draw entry.
14. Volleyball England accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering this Prize Draw or accepting the prize, except for any liability which cannot be excluded by law (including

personal injury, death and fraud) in which case that liability is limited to the minimum amount allowable by law.

15. The prize winner's name may be made available within the Volleyball England website and its social media accounts if the prize winner consents to this.
16. If for any reason any aspect of this promotion is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the Promoter which corrupts or affects the administration, security, fairness, integrity or proper conduct of this promotion, the Promoter may in its sole discretion cancel, terminate, modify or suspend the promotion or invalidate any affected entries, where required.
17. Participants in the draw are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The promoter reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.
18. These terms and conditions shall be governed by English law and the courts of England and Wales shall have exclusive jurisdiction.
