INITIAL CHECK:

If you have played Volleyball in another country after you turned 14 years old, your Federation of Origin may be "Not England". Before starting the below processes, please check by emailing competitions@volleyballengland.org.

This applies to both renewing and new NVL players.

1. Purchase the NVL (Federation of Origin – England) registration on VolleyZone



2. Registration will be marked as active on VolleyZone



3. Player will be eligible to compete in the 26/27 NVL season

*Expected timescale (registering to becoming active on VolleyZone): 10 minutes

1. Purchase the NVL (Federation of Origin – NOT England) registration on VolleyZone (registration will be marked as inactive)

4. Sign your ITC once it has been initiated

5. Once your ITC has been completed, you will be notified via email. VE will activate your VolleyZone account

6. Player will be eligible to compete in the 26/27 NVL season

VE: Volleyball England
VIS: Volleyball Information System
ITC: International Transfer Certificate

*Expected timescale (registering to becoming active on VolleyZone): 3 days to 2 weeks (depending on speed of parties signing the ITC)

1. Go to the VISA website to obtain a share code [here](#) to prove your status



2. Purchase the NVL (Federation of Origin – England) registration on VolleyZone (will be marked as inactive)



3. The VE Competitions Team will conduct a visa check and ensure it meets the NVL Regulations (link [here](#))



4a. If it doesn't meet regulations



5a. Registration will be inactive and the Competitions Team will contact you



4b. If it does meet regulations



5b. Registration will be marked as active on VolleyZone

Please note if your VISA expires prior to 1st May 2027, you will be ineligible to compete in the NVL from the VISA expiry date. If you extend or change your VISA, please notify competitions@volleyballengland.org with your new share code.

*Expected timescale (registering to becoming active on VolleyZone): 1-3 working days

*If you are a new member to a club, please ask a club admin to approve your new registration through their admin account on VolleyZone

3. Once your ITC has been completed and your VISA has been checked, VE will activate your VolleyZone account
