SAFEGUARDING TRAINING REQUIREMENTS



These safeguarding training requirements list out the minimum requirements for you to safely complete your role within volleyball activity. This includes completing safeguarding courses and/or a DBS check.

If DBS check is listed against the role, you will be undertaking, please read the information below about regulated activity.

What is 'Regulated Activity'?

- 'Regulated activity' includes teaching, training, instruction, caring for, coaching or supervising children (u18s), where that activity is done unsupervised and frequently.
- 'Frequent' is defined as more than 3 days in a 30-day period or once overnight between 2am and 6am (unsupervised.)

A DBS check cannot be carried out for a person under the age of 16.
